# **B.** Origin & Directionality

1. Origin: US-KR via ATL-ICN

2. Directionality: As specified above.

#### C. Carrier

- 1. TPAC flights qualified for commission for origin US to ICN that includes ATL-ICN marketed by DL and KE and operated by DL flight 27. Routing and valid connecting points are reflected in the GDS fare quote systems.
- 2. Fares and travel are valid via flights operated by the "Delta Connection" carriers.

#### **D. Commission Qualification Terms**

- 1. Tickets must be plated on DL (006) and KE (180)
- 2. Tickets must be issued in US Dollars
- 3. Tickets must state "Non-Endorsable Refundable by Delta/Issuing Agency Only"
- 4. Commissions must be calculated against base fare prior to any taxes, surcharges, airport fees, customs user fees, passenger facility charges or other similar charges
- 5. Commission compensation must be taken at point of sale. Retroactive commission may not be claimed
- 6. Tickets refunded, exchanged or used on OAL are subject to recall of commission
- 7. Commission can be claimed with published fares and web fares and is NOT combinable with any other commission or CAT25/35 net fare program.
- 8. If the fare is eligible for a mark-up per DL's standard policies, add the mark-up to the commission claimed on the ticket and place the resulting value in the ticket's commission box
- 9. Travel: 24SEP-31DEC18 with blackout dates: 14DEC-22DEC18 for inbound and outbound flights
- 10. Ticketing valid from 24SEP18-8OCT18
- 11. All other rules not states herein are governed by the rules of the contract, program, or agreement through which the commission fare is derived. If the fare or itinerary is not valid in any DL contract, program, or agreement, commission may not be claimed
- 12. Bonus commission applies to web fares
- 13. This program is not combinable with any other CAT25/35 or commission programs.
- 14. Child fares are permitted

# E. Prepaid tickets are not permitted.

## **F. Exceptions:** No commission will be earned pursuant to this exhibit for the following:

- 1. Infant, student military, VUSA, or standby fares.
- 2. Blocked group space.
- 3. Corporate Fares

## G. Discounts
