### 1) DESCRIPTION OF PARTIES:

Whereas SAS is engaged in providing air transportation and whereas the Agent/Organizer is engaged in the business of developing, packaging and marketing travel tours to the public and whereas the Agent/Organizer and SAS desire to cooperate in selling their respective services to the public for their mutual benefit;

The parties agree as follows:

### 2) TERMS AND CONDITIONS:

- A) SAS agrees to provide Agent with: Flight Itinerary, Fare Basis, Net Fare, International fee (YQ), and Tax breakdown.
- B) Agent agrees: Not to make use of SAS' name, logo, color, pictures, or representation of SAS' aircraft in the Agent/Organizer's brochure(s) or website before being submitted to SAS for its prior written approval before any printing/display. The Agent will not assign or subcontract the agreement or any right or obligation hereunder.
- C) All requested flight itineraries are subject to schedule changes. This agreement applies only to the flight information/itinerary identified herein.
- D) A group is defined as a minimum of 10 passengers traveling roundtrip from a single origin to a single destination

### DEVIATIONS:

- A) 20% of a group of the group may deviate, however the main group still needs to be at least 10 passengers. Point of origin or destination may not deviate. All fares and flights are subject to availability at time of requested deviation.
- B) Deviations on routing are not permitted and must be booked, priced and ticketed separately from the group by the Organizer/Agent

### PAYMENT:

- A) Payment and/or deposit requirements are as outlined in ticketing instructions, which are attached hereto.

SAS and other airlines are obligated by law to give access to certain travel and reservation data for all passengers booked to/from/via USA. Personal Data, which has been provided to us in connection with your travel, may be passed to government authorities for border control and aviation security purposes.

- b. It is the responsibility of the Agent to obtain ticketing rules and instructions in their CRS/GDS System. Additional ticketing instructions can be found on [www.sassalesinfo.com/](http://www.sassalesinfo.com/) Groups For the rest of the world/Reservation/US Ad-hoc
- c. Tickets must contain the net price using SAS operated and designated flights and US domestic carrier's flights and routings as specified.
- d. Tickets must be issued using the applicable SAS group fare basis **GUSASKG**.
- e. Endorsement box must read: Valid only flights/dates booked/No Refund.
- f. ARC/IATA approved Agencies will issue their own tickets on SK/117 ticket stock. A fee of \$50.00USD per ticket will be collected if SAS issues the ticket for an ARC/IATA agent.
- g. For non IATA- approved Agents, Tour leaders or direct passengers there is a fee of \$35.00USD per ticket.
- h. All Tickets must be issued no later than 30 days prior to departure; Failure to issue tickets within deadline will result in seats being released and deposit forfeited.
- i. Passengers traveling on any separate tickets will not be covered under this agreements terms and conditions.
- j. Voided tickets within ticketing deadline are subject to an Agency Debit Memo (ADM) of the full net fare quoted. For further information on ADM, please refer to [www.sassalesinfo.com](http://www.sassalesinfo.com) Reservations/Policies & Agreements.
- k. It is the responsibility of the Agent to cancel any unwanted seats or the entire reservation in their own GDS, or to contact SAS Group Sales department to advise of cancellation. Failure to report cancellations may result in an ADM of the full net fare quoted.
- l. It is the responsibility of the Agent to enter the baggage allowance and fare basis on all tickets issued.
- m. It is the sole responsibility of the passenger to have all required travel documents.

### **NAME REPORTING AND DEADLINES:**

### **SAS will observe the following name and ticketing deadlines:**

- a. **90 days** prior: Please reconfirm number of seats by email.
- b. **40 days** prior: All passport names are due. Any seats without an assigned passenger name will be cancelled.
- c. **35 days** prior: Agent shall issue tickets within 5 business days.
- d. **30 days** prior: Failure to issue tickets on a group record will result in cancellation of entire group.

Names shall be inserted by the travel agent.

### **NAME CHANGE POLICY:**

After the applicable ticketing deadline, name changes are only permitted on wholly SAS flight itineraries. Any name change must be processed at latest 2 business days before departure with a fee payment of \$80.00 USD per person.
