**SERVICE AGREEMENT:** Buyer agrees to pay a deposit of \$300 per vehicle per day with the balance paid 30 days prior to the trip departure. We accept checks,cash,ACH payments or most credit cards to make payments. Deposits are refundable if charter is cancelled with at least 60 days prior notice. 50% of deposit can be applied to later date if cancelled between 45-60 days. No refunds on deposits if cancellation is within 45 days. If trip is cancelled within two weeks of date of service there is NO REFUND on payments. Monies paid, minus a 4% admin fee, can be applied as a credit for use on another trip. Trip MUST be rescheduled within 30 days of cancellation for use within one calendar year of original date of service. Service is non transferable and must be used by the original party. Though every effort is made to have all equipment in working order, amenities such as lavatory, video and audio are not charged for and therefore no credit will be issued if those amenities are not available or not functioning for any reason. Complete detail form/itinerary on all trips is required at least 4 days in advance. Changes submitted after final itinerary has been provided may result in an additional administration fee. Buyer will provide and pay for a separate room for each driver on any overnight trips. . Driver hours: Federal Department of Transportation safety regulations prohibit drivers to be on duty more than fifteen (15) hours per day, ten (10) hours of which are for driving (including a 30 minute pre and post trip vehicle inspection). The driver must be given eight (8) consecutive hours off before he/she may resume their duties. Any non-scheduled driving more then to and from the two locations must be approved prior to extra use. Damages to Bus: The cost of repairing damage to buses -"beyond normal wear and tear" from acts of member of the "Buyer's" party shall be charged to the "Buyer" and is payable as soon as such cost is determined. Buyer agrees to pay for these charges within 15-days of notice. Buyer agrees to pay legal fees and court cost if court action occurs-and if buyer is losing party. Unusual Cleaning: When members of the "Buyer's" party or the nature of the charter trip cause a

greater than normal amount of time and or materials will be necessary to clean bus properly upon its return to garage, the Operator, at its option, may require additional cost to cover such additional time and materials. Buyer agrees to pay for these charges within 15-days of notice, or will be automatically billed to the credit card on file. Minimum charge will be \$250. THG operates non- smoking vehicles only. Drug use is prohibited by law. Any fines will be paid for by the customer.

**AC Casino Trips ONLY:** Please select top three choices for Casinos in Atlantic City so that a reservation can be made. Minimum length of stay at most casinos is 6 hours. The Casino reserves the right to refuse any bus with intoxicated members on board. No riders under the age of 21 are permitted to arrive on chartered bus for Casino trips. We are not responsible for any changes to Casino packages. No refunds will be made for any of the above issues.
